

2014 WINTERS POLICE DEPARTMENT ADMINISTRATION

OFFICE OF THE CHIEF OF POLICE



The Chief of Police is the head administrator of the police department. The Chief oversees all aspects of the police department, which encompasses personnel, operations, budget, project management, policy, and resource management. The Chief continuously evaluates the method of police services and establishes best practices that best provide safety and protection to maintain the quality of life the community deserves.

POLICE SERGEANT

The Sergeant oversees much of the operations section of the police department and some administrative duties. Some of the Sergeant's responsibilities include budget, managing special projects, training management, evaluation of sworn officers, and help develop best practices for policies and procedures.



RECORDS DIVISION



- Records and Information System Manager Karla Ferguson continues to work with cutting edge technology to improve investigative information.
- A new records system for tracking property and evidence was installed. The system provides greater flexibility for pulling different reports and can track more informational fields.
- In 2014 the Records Division has assisted 1782 people at the front counter of the Police Department. The division has also processed 233 subpoenas, 27 restraining orders, and 173 warrants.

2014 WINTERS POLICE DEPARTMENT OPERATIONS

BACKGROUND

- Full– Service Municipal Law Enforcement Agency
- Total Sworn: 9
 - Chief of Police, 1 Sergeant, 2 Corporals, 4 Police Officers, 1 School Resource Officer, 6 Civilian Professional Staff, and volunteers.
 - Our professional staff included a Records Manager, Records Assistant, 1 Community Service Officer assigned to a range of duties including: Records, Crime Prevention, Crime Scene Investigation, and Property & Evidence Management. In addition to two 2 Chaplains and 1 volunteer.
 - Patrol area of approximately 2.8 square miles divided into four beats
 - Patrol Officers investigate all reported crimes, enforce traffic violations, and respond to the schools for matters of concern.
 - The School Resource Officer position was reinstated in October 2014.

ASSISTING OUTSIDE AGENCIES (AOA)

This entails officers responding outside the City to assist other law enforcement agencies within our area as back-up units, traffic control, checking for crimes in progress at the request of the outside agency.



- These agencies mainly consist of Yolo/Solano Counties and CHP. Reports are taken where Winters was requested to assist an outside agency:
- 2013: **103**
- 2014: **114**

*In addition to assisting agencies, Patrol Officers spent a total of 17 hours and 36 minutes out of the city due to transporting subjects to hospitals for medical clearances, jail and mental health matters. Most of that time was during swing and graveyard shift.

NEW OFFICERS




The Winters Police Department is proud to introduce these officers who replaced three other officers who left the department:

Volunteer Director/Chaplain Robert Duvall was hired as a volunteer October 2013


He has 17 years of law enforcement experience as a Contra Costa County Deputy. His desire was to continue serving law enforcement as a volunteer after his retirement.

2014 WINTERS POLICE DEPARTMENT PROFESSIONAL TRAINING

STAFF DEVELOPMENT

Providing our staff with the training they need to advance and perform their job duties more effectively continues to be a high priority of the Winters Police Department. The Department continues to seek out professional training to both satisfy state and federal requirements and to provide enrichment opportunities to our staff.

Officers and Staff have also used the P.O.S.T. Learning Portal to receive free on-line training. The employees receive P.O.S.T. credit and certifications for the completion of the on-line courses. This helps them receive accreditation to obtain Intermediate or Advance P.O.S.T. Certificates.

2014 WINTERS POLICE DEPARTMENT ANNUAL HIGHLIGHTS



RESIDENTIAL BURGLAR CAPTURED AND CONVICTED

On October 1, 2013 Officers were dispatched to a residential burglary. The victim advised that he was missing musical instruments and electronics. The victim's son located the suspect a few blocks away carrying one of the stolen instruments and spoke with him. He recognized the suspect as Oscar Cortez. Cortez told him that he had the victim's permission to take the items and left. When the victim and his son went to look for Cortez, he had disappeared. Officers conducted a neighborhood canvas and were able to recover a few stolen items. Officers then conducted follow up at the Cortez family residence and recovered more stolen items. Officers requested a felony warrant of arrest for Mr. Cortez. Oscar Cortez was arrested on a Winters Police Department Felony warrant of arrest charging him with burglary. Mr. Cortez was sentenced to prison for the burglary.

DOWNTOWN HOMICIDE

On November 18, 2013 Winters Police investigated the shooting death of Leslie Pinkston. The suspect was identified as William Gardner and warrant of arrest for murder was granted. Gardner was evading capture, so the department enlisted the help of the U.S. Marshal Service. On December 9, 2013, a tip was received that Gardner was in Las Vegas. Marshals were notified and were assisted by the Las Vegas Metropolitan Police Department [LVMPD]. Gardner was located, but barricaded himself in an apartment. After a several hour stand-off with detectives negotiating his surrender, Gardner surrendered to police.

DOWNTOWN HOMICIDE cont...

On December 30, 2013 William Gardner was extradited to the Yolo County Jail.

On October 30, 2014 A jury found William Gardner guilty of first degree murder.

On December 1, 2014 William Gardner was sentenced to life without parole.

VEHICLE BURGLARY—SUSPECT CAUGHT

On February 5, 2014, police investigated a report of a vehicle burglary. Suspects had stolen hi-tech electronic equipment and personal items. Officers were notified that a subject attempted to use the victim's stolen gift card at a business in Vacaville. Officers were able to gather information that identified the subject. On February 20, 2014 the Winters Police Department was notified by the Dixon Police Department that they initiated a traffic stop on a vehicle for expired registration tabs. The officer noticed items in the driver's possession that appeared to be stolen property in a recent Winters vehicle burglary investigation. Winters officers notified the victim who responded to Dixon and confirmed the items he could see in the vehicle was his property. The suspect was identified as Ryan Chase Micklon, age 23, from Fairfield. Micklon was charged with possession of stolen property as well as possession of a controlled substance and other violations. The suspect was transported by Dixon PD to the Solano County Jail where he was incarcerated. A search warrant was served to search the vehicle Micklon was driving and uncovered other stolen property. A warrant was requested for additional charges to the Yolo County District Attorney's office. He was charged with burglary and possession of stolen property. Micklon was sentenced to California Department of Corrections and Rehabilitation.

2014 WINTERS POLICE DEPARTMENT ANNUAL HIGHLIGHTS

GRAB AND RUN SUSPECTS NABBED AND CHARGED WITH BURGLARY

March 15, 2014 at about 1:32 am, Winters Officers were dispatched to a theft call at Winters Chevron. Officers spoke to the store clerk who reported that two suspects had just left the premises in a burgundy Cadillac after stealing two bottles of beer. Shortly after, a Winters Officer observed a vehicle matching the description. Winters Officers initiated a traffic enforcement stop on the vehicle and both occupants were detained. The passenger was identified as Damon Flores - age 25, transient and the driver was Oscar Ochoa - age 28, a Winters resident. The store clerk arrived to the traffic stop and positively identified the vehicle, and both subjects involved in the theft. Officers conducted a search of the vehicle and found an empty bottle of beer, which was confirmed by the store clerk to be the same brand stolen from the store. Flores admitted to preplanning the theft of the beer with Ochoa before entering the store. Both suspects were placed under arrest and charged with burglary and conspiracy to commit a crime. Ochoa had additional charges of driving under the influence and driving with a suspended/revoked driver's license. Both suspects were taken to Yolo County Jail.

POLICE CAPTURE SUSPECT ATTEMPTING TO HIDE IN CREEK

On May 1, 2014 at about 10:17 am, Jerod Martinez was arrested by the Yolo County Sheriff Office on a Probation Department issued felony bench warrant. He was charged with a violation of his post release community supervision (PRCS). Martinez was on PRCS regarding a previous Winters Police Department case in which he was charged with vandalism, possession of a controlled substance, and infliction of a corporal injury on a cohabitant. Martinez was transported to the Yolo County Jail for booking and incarceration. Martinez initially fled from Officers on foot before being captured. Officers conducted a search of Putah Creek and surrounding areas and were assisted by a Fish and Wildlife Warden and a California Highway Patrol helicopter.

2014 WINTERS POLICE DEPARTMENT ANNUAL HIGHLIGHTS

BRIDGE ACCIDENT CLAIMS LIVES OF TWO WORKERS

On May 30, 2014 Winters Police Officers and Winters Firefighters responded to the Winters bridge on Railroad Avenue for a report of an industrial accident. When responders arrived on scene they located two individuals who had lost their lives falling from a crane. Officers and Firefighters worked together to secure the scene, comfort the other members of the construction crew, and recover the deceased individuals. Members of the Dixon and Yocha Dehe Fire Departments responded to assist as did members of the Yolo and Solano County Sheriff Office. Individuals from Winters City hall including Mayor Aguiar-Curry and City Manager Donlevy also assisted first responders with managing the scene. Police Chaplains were called out to support the family and workers.

CATALYTIC CONVERTER THIEVES CAUGHT WITH BURGLARY TOOLS

On July 9, 2014 at approximately 2:50 am, a Winters resident contact the Police Department about a suspicious vehicle. The resident stated he saw the driver and passenger exit the vehicle, look under a vehicle, and disappear. When the Officer arrived he located two people hiding in bushes along a residence. The Officer searched the people and located several tools. Due to several catalytic converter thefts in the area, the tools, and statements from the suspects and witnesses the Officer arrested both suspects. Leng Moua, 43, of Sacramento was arrested for possessing burglary tools, delaying/resisting a Police Officer, and violation of parole. Kong M. Vang, 35, of Sacramento was arrested for possessing burglary tools, delaying/resisting a Police Officer, and violation of probation. Moua and Vang were booked at Winters Police Department and transported to Yolo County Jail for incarceration.

2014 WINTERS POLICE DEPARTMENT ANNUAL HIGHLIGHTS

APARTMENT MANAGER ARRESTED FOR EMBEZZLEMENT

On August 25, 2014 Officers were called to the Orchard Village Apartment complex for a report of embezzlement. The apartment management company had discovered a pattern of missing money for several months. The suspect was the on site manager. Officers worked with the management company and determined the amount of money missing totaled over \$14,000. Laura Vasquez was arrested on a charge of embezzlement. Over the next several months Officers compiled a report and served search warrants. Ultimately Mrs. Vasquez was ordered to pay \$14,026 in restitution .

MAN HAVING MENTAL HEALTH CRISIS LOCKS HIMSELF IN HOME

On September 10, 2014 at approximately 3:46 pm, Winters Officers received a call regarding a possible assault with a deadly weapon on the 400 block of Baker Street. The subject was believed to have been armed with a knife and experiencing mental health issues. Officers responded and determined that the subject had not harmed anyone, but had locked himself inside a room. Winters Officers attempted to contact the subject, who did not respond to Officers' instructions. Officers secured a perimeter around the residence and requested assistance from the Yolo County Sheriff Department and Crisis Response Team. Officers and Deputies were able to contact the subject who later surrendered himself without any further incident. The subject was transported to the Woodland Memorial Hospital for a mental health evaluation.

TWO TEENAGERS FIGHT ENDING IN STABBING

On November, 29, 2014 a 15 year old Winters teenager turned himself into the Winters Police Department confessing to the stabbing of a 16 year old Winters male teenager during an altercation in front of the Winters Library that occurred November 26, 2014. The incident originated when the Winters Police Department was dispatched to the area on Grant Ave and Railroad Ave for a report of a victim of an assault. Officers were led to the 700 block of Apricot Ave before locating the victim at his residence. The victims injuries were determined to be non life threatening and the victim was in stable condition. The suspect was arrested and charged with assault with a deadly weapon. He was booked at the Winters Police Department and transported to the Yolo County Juvenile Hall for incarceration.

2014 WINTERS POLICE DEPARTMENT ANNUAL HIGHLIGHTS

SUSPECT ARRESTED FOR STALKING EX-GIRLFRIEND

On December 3, 2014 at approximately 8:30 am, an Officer contacted an individual in the front lobby of the Police Department regarding a stalking case. The individual shared her history with an ex-boyfriend, Gary Johnson, and her concerns that he was stalking her. After an investigation, Officers submitted a search warrant for Johnson's residence finding evidence relevant to elements of stalking. Soon after, Officers submitted the case to the Yolo County District Attorney's Office for review and a warrant was granted in the amount of \$250,000. After arraignment on charges of stalking and other related charges a judge amended Johnson's bail to \$1,000,000. The case is pending trial.

MAN STABBED AFTER FIGHT—SUSPECT ARRESTED

On December 14, 2014 at approximately 4:16 am, Officers responded to the Chevron Gas Station on the 900 block of E. Grant Ave for a report of a 23 year old Vacaville man who had been stabbed multiple times. Officers conducted an investigation and requested a felony warrant for Johnny Lopez, 24, of Winters. On April 9, 2015 at approximately 7:49 pm, Officers received a phone call from the Department of Homeland Security notifying them that Mr. Lopez had crossed the US/ Mexico border into California and had surrendered himself to law enforcement. On April 14, 2015 Mr. Lopez was transported to the Yolo County Jail. Mr. Lopez was booked on a Winters Police Department felony warrant of arrest charging him with attempted murder, using a weapon in the commission of a felony offense, inflicting great bodily harm in the commission of a felony offense, and specific intent to commit a crime.

CSO Gail Jimenez was a huge asset to the department and played a key role in several cases helping officers with their investigations.




2014 Officer of the Year

Officer Gordon Brown was selected Officer of the Year for helping solve several cases. He has been actively involved in community outreach and coordinated youth related events.


2014 Commendations

2014 WINTERS POLICE DEPARTMENT SCHOOL RESOURCE OFFICER



The School and Youth Resources Section is a section within the Winters Police Department assigned to handle most youth related issues. The issues consist of investigating crimes against children and crimes committed by juveniles. The section also is in charge of the juvenile diversion program and serves as a liaison between the Police Department and the Winters Joint Unified School District. The School and Youth Resources Section is a support position for the department and responds as a backup officer when needed.

The Winters Police Department has partnered with the Winters Joint Unified School District, Yolo County District Attorney Office, Yolo County Probation Department, and Yolo County Child Welfare Services, and Winters Community Groups to participate in School Administrative Review Board (SARB) meetings. These meetings provide a chance for students with truancy issues to undergo District Attorney Mitigation before their cases are turned over for prosecution under the California Education and Welfare Codes. Each participating agency is given the opportunity to provide their services to parents and students.

Officer Brown has been assigned to the School Resource Officer (SRO) position. He has quickly begun working with school personnel and others within the agency to implement the Youth Diversion program. Officer Brown has also begun to develop his own programs and outreach to supplement the SRO program.

2014 WINTERS POLICE DEPARTMENT COMMUNITY OUTREACH

CHAPLAINCY PROGRAM

The Winters Police Department continue to work with Chaplains Jim Wilson and Robert Duvall. Their duties consists of consoling family members with tragic and untimely family deaths, mentoring youth and adults alike, and providing emotional and spiritual support for all citizens and employees of the City of Winters. They can be called on to provide these critical services on a moments notice at all hours of the day and night. Both Chaplains bring a tremendous amount of knowledge, professionalism, and support to the City of Winters.



INTERN PROGRAM

The Winters Police Department participated in the City Intern Program for the second time this year. During the summer the Department welcomed Nicole Martinez as the new Police Department Intern. Intern Martinez has worked on a variety of projects during the summer that included filing, transportation, fleet maintenance, evidence processing, helping to coordinate operations at the gun range, and assisting with translation for Spanish speaking citizens. She has also been a driving force behind revamping the Youth Diversion program.



2014 WINTERS POLICE DEPARTMENT COMMUNITY OUTREACH



VOLUNTEER PROGRAM

In addition to the Chaplaincy program, Robert Duvall also administers the Winters Police Department Volunteer Program. He developed policies, uniforms, training, duties and procedures needed to implement the program.

The Winters Police Department now has a volunteer program registered under the nation wide program Volunteers In Police Service or VIPS. Two volunteers have been accepted into the program, Robert Duvall and Nicole Martinez .

Nicole Martinez started as the Police Department's Intern. After the internship ended she stayed on to volunteer. Martinez has continued to help records personnel with property and evidence record entries, she has assisted patrol with translation, and she assisted in evidence collection and processing.

2014 WINTERS POLICE DEPARTMENT COMMUNITY OUTREACH

SOCIAL MEDIA

The Winters Police Department has launched several projects to increase positive interactions with the community. The Department continues to expand its social media programs being cognizant that there is a fine balance between keeping up with current trends and making sure disseminated information is accurate. Staff have received training on interacting with the public via social media and are continually looking for new ideas and ways to improve.

The Department Facebook page has been growing as staff remain diligent in posting community events, interesting public safety related stories, crime tips, and information from partner agencies. As a result, more residence have been interacting with the page which has reached over 900 likes.

Nixle provides communication between subscribers and public safety agencies through text, email, voice messages, social media, and the Nixle mobile app. Subscribers to the program can set their alert level and how they would like to be notified about various topics such as community events, crime tips, amber alerts, missing people, or wanted persons.


The Records Division continuously collects and enter data, which is reported to the Yolo County Probation Department each month for evidence based purposes.

CALLS FOR SERVICE—REPORTS—RESPONSE TIMES

A “call for service” is a request for police service in which an officer is dispatched, or an incident initiated by a police officer. A phone call to the police does not necessarily generate a call for service and not every call for service generates a crime report. Response times were also provided illustrating officers arrival times to a call for service based on priorities. Disp = Dispatched; Enr = Enroute; OS = On-Scene



PART 1 CRIMES AND ARRESTS

The Police Department collects statistics all year for the nation wide statistical Uniform Crime Reporting Program (UCR). The information provides national criminal statistics to other law enforcement agencies and the general public.

UCR is administered by the Federal Bureau of Investigation (FBI). Statistics for participatory agencies are published on a regular basis and can be downloaded from the FBI web site. The UCR Part I offences include: Homicide, Rape, Robbery, Aggravated Assault, Burglary, Larceny– Theft, Motor Vehicle Theft, and Arson.




PHONE IN ONE HAND, TICKET IN THE OTHER PROGRAM

The Winters Police Department has teamed up with The California Office of Traffic Safety (OTS), the U.S. Department of Transportation's National Highway Traffic Safety Administration (NHTSA), the California Highway Patrol, and 36 other law enforcement agencies across the greater Sacramento region to eliminate motorists' hand-held cell phone use and texting.

Mobilization is supported by national and local paid advertising and media campaigns aimed at raising awareness. The program was locally administered by Corporal Ramos.

Winters participated in several enforcement periods through out the year.



DUI WARRANT SWEEP

Winters participated in a County-wide program which focuses on locating suspects who hold a DUI warrant.

AVOID THE 8 PROGRAM

The Winters Police Department was pleased to participate in the AVOID program this year. The overall goal of the campaign is to warn drivers that the only way to "AVOID" the county's law enforcement officers is to drive sober. The program is administered by the Davis Police Department, the Winters Department liaison were Sgt Jose Ramirez and Corporal Warren.

AVOID events are rotated throughout the county in a combination of check points and saturation.
