RESOURCES—LICENSING

This brochure is designed to be a guide to the Business Licensing process to help save you time and money on your project.

WHERE TO START

The Community Development Department coordinates the City's development and assists projects through the development process.

Assistance includes:

- Identifying what types of City Permits are required for your project.
- Coordinating with other City departments for "pre-submittal" meetings that can be used for identifying any potential issues associated with your project.
- Tracking the progress of your project through the process.

If you would like more assistance, or need further information, please contact the Community Development Department at (530) 795-4910 x112.

The Community Development Department also provides information on land use, zoning, site development standards and general plan policies. Community Development also processes and analyzes development applications. Businesses should contact the Community Development Department to confirm their proposed use or expansion is consistent with the business site's zoning and to identify if any use permits and /or CEQA review are required.

The Building Department is responsible for ensuring compliance with all necessary code requirements. If you are unclear of building improvements and if permits are required for your new expanded business, please contact the Building Department at (530) 795-4910 x112.

The Public Works department provides major services for customers throughout the community. These services include water, wastewater, and solid waste. If your business involves a change of use (e.g. from office to restaurant) you may need to ensure there is adequate water and sewer service available at the site. For more information regarding design, maintenance and operations of these utilities contact Public Works at (530) 795-4910 x115.

The Economic Development Department provides economic assistance through programs and services designed to retain existing employers, encourage company expansion and attract new businesses to the community. For further information on the available types of programs and services, please contact Economic Development at (530) 795-4910 x118.

BUSINESS LICENSE

If you own or operate a business in Winters, you will need to obtain a business license. The Community Development Department processes applications for business licenses. 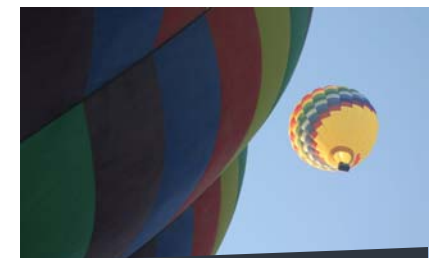
